

## The Value of Lippincott CE

I'm Karen Innocent, Executive Director of continuing education for Wolters Kluwer and I'm going to talk about the value of Lippincott continuing education. Before someone invests in continuing education, you need to answer a few questions and find out that the content behind the CE matters. What content is the source of the continuing education that you're seeking? Is it from general content for any type of user or is it specific to the needs of your audience or your own particular goals as a professional? Is the content peer-reviewed? Is it based on the principles of evidence-based practice? Is the provider accredited or an approver? And how long has that provider been around? Are you able to get access to your records in the future? Continuing education is more than just amassing credits or earning certificates. Continuing professional development is lifelong learning. It is the process of tracking and documenting your education that you have learned over time. It can be from formal or informal learning and it is from experiences that you've had as well as educational offerings that you've participated in. Continuing professional development can be from a number of different ways that you can earn it. Practically speaking, continuing education is a method of learning formally or it is an informal way of getting education to develop yourself as a professional. And it is the underlying practice and skills and competencies that forms your career. Let's look at the reasons for taking CE. For the individual there is continuing education requirements for license renewal and in the U.S. more than fifty percent of the states require continuing education. And also individuals who have board certifications need to take continuing education in order to maintain their certifications. And in general, all professionals need to have continuous professional development in order to stay current in their practice. For institutions there are different reasons for earning continuing education or for providing continuing education to employees. One of those reasons is accreditation. For example, there's Joint Commission Accreditation



for various disease specific topics that institutions must maintain. In order to maintain those certifications they must require that their employees take specific courses. Also, there's areas to support the ongoing quality improvement of an institution and there's some standards that have been set by the Center for Medicare and Medicaid Services that requires that employers provide mandatory training to their employees to meet those quality standards. And then there's still some other opportunities that institutions will follow through on such as the attainment of ANCC magnet status. So there's institutions that provide continuing education and support their employees toward professional development to attain additional awards and recognition as an institution. So better education equals better outcomes and better reimbursement for institutions. What is continuing professional development? Continuing professional development for the individual means the active participation in one's own life-long learning. It can be any type of activity, whether it's formal or informal, that the individual engages in, including conferences and seminars and workshops, continuing professional development is participating in continuing education and it is really the hallmark of being a professional. What is the process of continuing professional development as a process? Continuing professional development consists of learning activities that add to a nurse's or other health professionals foundational and experiential learning. Along with increasing the knowledge, skills, attitudes, and values, they support a professionals' improvement in their practice role. These activities may affect their clinical practice, education, research, administration, theory development and outcomes improvement. All that will eventually benefit patient outcomes. What about mandatories and competencies? Now mandatories and competencies are usually associated with institutions. Mandatory education focuses primarily on safety and there are courses that are provided by an employer to support national or state governmental agency licensing and also accreditation. Competencies are knowledge and skill based educational programs that support the knowledge and skills needed to support one's role in an organization for different level and organization or one specialty and they are specific programs that can be developed by the institution where one works or made available by organizations like Lippincott. Now how do we provide continuing education to the public? At Lippincott we
